**DIRECTIONS:** SHAKE CAN WELL BEFORE USING. Remove protective cap before using. FOR CONTROL OF WASPS, BEES, HORNETS AND YELLOW JACKETS. From a distance of 2 to 2.5 metres (6 – 8 feet), with wind coming from behind, point nozzle in direction of insect nest. Depress nozzle and continue spraying until the opening of the nest is completely covered with insecticide foam. If nest is accessible, allow sufficient time for insects to become inactive before destroying the nest. APPLICATION TO NESTS SHOULD BE MADE DURING EARLY MORNING OR LATE EVENING WHEN INSECTS ARE AT REST.

**LIMITATIONS:** Do NOT use inside homes, on humans or animals. Do NOT use as a space spray.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** May cause skin and eye irritation. Avoid contact with skin, eyes and clothing. Do not inhale spray mist. Harmful if swallowed, inhaled or absorbed through the skin. Provide adequate ventilation of the area being treated. Wash thoroughly with soap and warm water after using. Do not allow children or pets to contact treated area after application until surfaces are thoroughly dry. Cover or remove exposed food before use. Do not contaminate food or food containers, utensils or food preparation areas. Toxic to bees, fish and wildlife. Remove pets and cover fish ponds before spraying. Do not contaminate any body of water. Do not contaminate animal feeding areas. Contents under pressure. Do not place container in hot water or near heat source. Do not store or use above 50° C as container may burst. Avoid freezing. Do not puncture or incinerate container.

**FIRST AID:** If on skin, wash immediately with soap and warm water. If in eyes, flush with clean water for 15 minutes. If irritation develops, contact a physician. If swallowed, obtain medical attention at once or contact a poison control centre. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**DISPOSAL:** When container is empty, press nozzle to release all pressure. Do not reuse. Wrap in newspaper and discard in household garbage. Do not throw into fire.
