GENERAL INFORMATION

Chondrostereum purpureum is a naturally occurring fungal organism commonly found in the temperate deciduous forest. It plays a beneficial role in wood decay and recycling processes. When applied to stems, freshly exposed by transverse cutting close to the ground, it colonizes the stump and inhibits sprouting and regrowth. Subsequently, decomposition of the wood is accelerated. Myco-TechTM Paste increases the efficiency of mechanical cutting operations by reducing the increased density of stems, which often occurs following a mechanical cut. The fungus is active only on susceptible deciduous woody species, with the level of activity varying amongst species in relation to their regenerative sprouting ability.

DIRECTION FOR USE

Myco-TechTM Paste must be applied during the growing season, from early spring to early fall (i.e., June to September) and when conditions are conducive for fungal growth and development. Spread a thin layer of product over the surface area of freshly cut stumps within 30 minutes of cutting. A single topical application is sufficient to colonize the stump and inhibit sprouting and regrowth on the following species: birch, pin-cherry, poplar/aspen, and red and sugar maple. Treatment of a typical population of 30,000 stems per hectare will require about 30 L of Myco-TechTM Paste (on average 1 mL per cut stump). The degree of efficacy achieved may be affected by seasonal growth variations as well as the occurrence of heavy rainfall immediately before or soon after application.

PRECAUTIONS

May cause sensitization. Avoid contact with skin, eyes or clothing. Wear a long sleeved shirt, long pants, shoes plus socks, waterproof gloves, and eye goggles when handling, mixing/loading or applying the product and during all clean-up/repair activities. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash with clothing detergent and hot water before reuse. Keep and wash protective clothing separately from other laundry.

Do not apply directly to water or to areas where surface water is present or to intertidal areas below the mean high water mark. Keep out of lakes, ponds, or streams. Do not contaminate water by cleaning equipment or disposing of equipment washwaters.
