LIQUID POOL SHOCK is a high strength sodium hypochlorite solution which exhibits excellent algaecidal and disinfectant properties. Proper use of LIQUID POOL SHOCK in conjunction with a regular maintenance programme will give a sanitary pool free of harmful micro organisms.

DIRECTIONS:

Water Chlorination: Add LIQUID POOL SHOCK daily to maintain 0.6 - 1.0 (1.0 - 1.5 in stabilized pools) parts per million of residual available chlorine (PPM Cl₂). Daily charge depends on air temperature, number of people using pool and dirt load.

Algaecide and Shock Treatment: Add 375 mL LIQUID POOL SHOCK for every 10,000 litres of water and circulate for at least 8 hours. If algae persists have water tested at the store. Do not use pool until available chlorine has fallen to 2.0 PPM Cl₂.

pH Control: Before adding to pool, adjust pH to 7.2 to 7.6. Add muriatic acid or sodium hydrogen sulphate if high, soda ash if low.

Wading Pools: Add 5 mL LIQUID POOL SHOCK for every 100 litres of water daily.
