ROSES	Powdery Mildew, Black Spot Rust. Combination spray to control Powdery Mildew, Black Spot Rust, Aphids, Red Spiders, Thrips and Leafhopper.	Dust or spray every 7-10 days during the growing season 50g (3 Tablespoonfuls), FLOTOX Garden Sulphur 15 mL (1 Tablespoonful) ISOTOX Insect Spray per 5L of water.
DAHLIAS, CHRYSANTHEMUMS PEAS, BEANS	Powdery Mildew, Black Spot Rust	Dust or spray every 7-10 days during growing season. Preharvest interval for Peas and Beans is 1 day. Apply when infection appears.
GRAPES	Powdery Mildew	Spray when mildew first appears and repeat after 10 days. Continue spray as necessary. Preharvest interval 1 day except when grapes are used for wine then the interval is 21 days. Do not use on sulphur-sensitive varieties such as Concord.
SWEET CHERRIES	Brown Rot, Leaf Spot, Powdery Mildew	For Brown Rot and Leaf Spot spray FLOTOX from bloom up to 1 day before harvest. If weather is wet at harvest spray between pickings. For Powdery Mildew spray at husk-fall and repeat in 10 days.

SOUR CHERRIES	Brown Rot, Blossom Blight, Powdery Mildew, Rust Mite	Apply FLOTOX at bloom for Blossom Blight. For Powdery Mildew control spray at first, second and third cover. For Rust Mites apply FLOTOX in summer sprays. Preharvest interval 1 day.
PEACHES, PLUMS	Brown Rot, Leaf Spot Scab, Powdery Mildew (Peach), Brown Rust (Plum), Black Knot (Plum)	For Brown Rot, Leaf Spot, Brown Rust, Black Knot and Scab control apply spray at pink, bloom, shuck, cover and pre/harvest. If wet during picking, spray between pickings. For Powdery Mildew control in Peaches, spray at husk-fall and again in 2 weeks. FLOTOX can be used up to harvest.

APPLES, PEARS	Powdery Mildew, Scab, Rust Mites	Apply a spray in a regular protective schedule from green tip up to and including first cover spray. Depending on mildew conditions and temperature, rates may be slightly reduced after the first cover. During wet weather additional treatments may be needed. Apply FLOTOX in summer sprays for Rust Mite control. Preharvest interval 1 day.
TOMATOES	Russet Mite	Dust or spray when fruit begins to set. Repeat treatments as necessary. Preharvest interval 1 day.
CURRANTS	Powdery Mildew, Rust	Spray immediately before the earliest blossoms open and continue applications through harvest. Preharvest interval 1 day.
GOOSEBERRIES	Powdery Mildew	Spray immediately before the earliest blossoms open and continue applications through calyx. Do not use on sulphur sensitive varieties.

As a Spray-Mix 50g (3 Tablespoonfuls) FLOTOX Garden Sulphur in a small amount of water, stirring until a thin paste is formed, then add water to make 5 litres of mixture. Stir thoroughly. Do not store diluted spray. Make new dilution for each use.

FIRST AID: Avoid contact with skin or eyes. In case of eye contact, immediately flush eyes with plenty of water. Get medical attention if irritation persists. Wash hands after use. If swallowed, induce vomiting. Repeat until vomit is clear. Obtain medical attention.
