DIRECTIONS FOR USE: Mixing CARZOL SP water soluble package is completely soluble in water. CARZOL SP is not stable in alkaline water. Preparation a pre-mix or slurry before adding to the spray tank is not necessary. Fill the spray tank with one-half of the total amount of water to be used. Prepare the spray mixture just before application and spray entire contents of tank within 4 hours. Open the box and interior foil pouch and drop the water soluble bag into the spray tank. The bag will dissolve completely in 5-10 minutes. One bag will treat one (1) hectare. Fill the tank with the additional quantity of water required and then start the agitator. CARZOL SP is compatible with most commonly used insecticides and fungicides except lime and Bordeaux mixture.

CROP: Peach, Nectarine.

INSECT: Two-Spotted Spider Mite, European Red Mite.

METHOD: Apply when a threshold of 5-10 active mites per leaf are reached (mid-July to early August). The majority of the mite population should be in the young nymphal stage. Use sufficient water for good coverage of foliage. Direct nozzles of airblast sprayer into the targeted Peach/Nectarine tree orchard when spraying the border rows. Do NOT apply when the prevailing wind direction will cause drift from treated areas into lakes, ponds and other waterways. When using concentrate spray, apply same quantity of CARZOL SP per hectare as for dilute spray. Do not apply later than 21 days before harvest. Do not apply more than once per year.

RATE: 250-500 g CARZOL SP per 1000L water, or 1.1 Kg CARZOL SP per hectare.
