DIRECTIONS FOR USE

DIRECTIONS: C-I-L[®] Slug Bait Meal attracts and kills slugs and snails. These destructive pests do their damage at night and are rarely seen in the daytime as they hide in dark, damp places. As slugs and snails travel around the garden searching for plants of their choice to eat, it is recommended that the entire garden be treated.

For best results, the areas to be baited should be damp prior to application. Place small mounds of bait (70 mL in volume or ¼ cup) around the garden and between plants, at intervals of approximately 2 m. Cover mounds with boards, bricks, flat stones, etc. Covered bait stations are more attractive to slugs and keep bait out of reach of dogs, cats and birds. Be sure all bait is on the ground and none is left on foliage of fruits and vegetables.

Repeat applications at 10 to 14 day intervals if further control is required. Remove and dispose of dead slugs and snails each morning.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS. Avoid contact with skin, eyes and clothing. Harmful if swallowed. Avoid breathing dust. Avoid contamination of feed, foodstuffs, water supplies and ponds. Do not contaminate edible parts of food crops. Wash hands after use. **DOGS AND CATS ARE ATTRACTED TO METALDEHYDE BAITS. POISONING WITH FATALITY MAY RESULT FROM INGESTION.** Keep pets from treated areas.

STORE IN A DRY PLACE.

FIRST AID: If on skin, wash with soap and water. **If in eyes,** rinse with water for 15 minutes. If irritation develops, consult a physician. **If swallowed,** induce vomiting by giving 1-2 glasses of water and touching the back of the throat with a finger or a blunt object. Never give anything by mouth to an unconscious person. Call a physician or poison control centre immediately. Take container, label or product name and P.C.P. Registration Number with you when seeking medical attention.
