## DIRECTIONS FOR USE

**BARRIER APPLICATION:** For a 10m x 10m building site, apply a band width of 6 cm to the total outside perimeter of the average site. Avoid using around air vents.

Use 30 mL to 60 mL per 0.5m<sup>2</sup>. For mice, spray in areas where droppings are found and areas accessible to mice. Use on pipes leading into and outside of the house, garbage and refuse areas, storage areas, loading docks, entrance areas and surrounding doors, windows and foundations. Avoid direct spray on electrical equipment and appliances. Provide adequate ventilation for area being treated.

House mice nest and range 5 to 10 meters from their food source. Look for nesting areas where mice are sited and treat these sites. Cedar Mice Repellent can be used to make these sites less attractive to drive mice out of the infested areas into areas where bait and traps exist. Create odor barriers around desired sites.

When used as directed, the mice may choose to abandon their established nesting and feeding areas.

**CLEAN** -- When used as directed these products leave no oily residue on merchandise, machinery, furnishings, counters, or other surfaces.

### FIRST AID:

**Eye contact** -- flush immediately with cold clean water for at least 15 minutes. Contact a physician immediately.

**Skin Contact** -- the affected area should be thoroughly washed with soap and water. Flush with large quantities of water. If irritation persists, call a physician.

**Inhalation** -- remove to fresh air and contact a physician if necessary.

**Ingestion** -- Administer water or milk to dilute. Contact a physician or local poison control centre immediately.

**DISPOSAL:** Do not reuse empty container. Wrap container, put in garbage.

**STORAGE:** Store away from heat, sparks and open flame in original container and in area inaccessible to children.
