DIRECTION FOR USE:

One liter of Decco 273 Aerosol is normally enough to treat 25 tonnes of stored potatoes. Apply at a rate of 1 Kg active ingredient per 50 tonnes of potatoes. For long storage periods, residue samples should be taken throughout the storage period. If the residues observed fall below the recommended level, repeat application.

If it is known that the potatoes are to be held in storage for 4-6 months, the applicator can use 2 Kg of active ingredient per 50 tonnes of potatoes. For shorter storage periods, use 1 Kg of active ingredient per 60 tonnes of potatoes. The initial amount of residue will determine the anti-sprouting properties under identical conditions.

Apply this product by fogging type applicators which heat the liquid in a hot gas stream to the vapor state and then allow the issuing vapor to cool to a mist of fine particles. This equipment should be used as directed by the manufactures. Apply this product to the potatoes stored in storage rooms equipped with air circulating fans.

Decco 273 Aerosol should be used for post harvest sprout inhibition on cured potatoes only. CIPC will prevent suberization (wound healing or periderm formation) on injured potatoes and should be used only after a two weeks minimum healing period for the tissue injuries prior to its application.

Do not use on seed potatoes. Do not bring seed potatoes into storage that has been treated until the storage room has been cleaned and disinfected and dried. CIPC will prevent or delay sprouting of planned seed potatoes. Decco 273 Aerosol is a liquid at normal temperature. If the container has been subjected to cold weather, warm the container by placing it in warm water. Once opened, use the entire contents of the container.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN

Avoid inhalation of spray. Wash hands after use. Do not remain in treated area. Do not contaminate food or feed. Do not contaminate feed or water trough. Harmful if swallowed. Do not take internally.
