ROUNDUP(R) is a non-selective vegetation control herbicide that controls most annual and perennial grasses, including lawn grasses, broadleaf weeds and brush (i.e. virtually anything that is green and growing). A systemic herbicide, it is absorbed by the leaves and moves throughout stem and roots to control the entire plant. Visible symptoms of control take 1 week or more with burndown in 2-4 weeks.

NOTE: ROUNDUP has no soil activity and will not leach or run off to affect nearby vegetation. Plants must be present to be controlled. Repeat applications will be required as new seedlings and vegetation emerge.

NOTE: AVOID SPRAY CONTACT ON DESIRABLE PLANTS AS ANY PLANT MAY BE KILLED BY CONTACT.
