**GRASS SPECIES EFFECTIVELY RETARDED WITH MAINTAIN CF 125:** Creeping red fescue, Kentucky bluegrass, couch grass, red-top, ryegrass, smooth brome, intermediate wheatgrass, timothy, wild barley.

# DIRECTIONS FOR USE

## **GRASSES, BROADLEAF WEEDS**

**USES: MAINTAIN CF 125** effectively retards many grasses and controls broadleaf weeds.

**WHERE TO USE:** Rights of way, median strips, culverts, guard rails, around sign posts, under security fences, sub-stations, and ditch or steep banks.

**WHEN TO USE:** On established turf best results are obtained when treatments are applied in the spring when grasses are just beginning to green up, and are 5 to 8 cms high, or 3 to 5 days after first spring mowing in situations where ample rainfall promotes rapid and sustained summer regrowth. Applications may be made throughout the growing season for effective broadleaf weed control.

**RATES:** Use 22 to 35 litres of **MAINTAIN CF 125** per hectare, or a combination of 11 litres of **MAINTAIN CF 125** plus 5.6 kg of maleic hydrazide (3.36 kg ai) per hectare in 500 L/ha of spray solution.

Even application to insure uniform wetting or grass and herbaceous weed foliage is essential for most effective results.

The combination gives the user the benefit of the separate retarding action of each material, plus an increase in effectiveness over either material used independently. **MAINTAIN CF 125** should be well mixed with water before maleic hydrazide is added. Continue agitation during spraying operation.

Do not mow turf and weeds until all evidence of growth retardation has disappeared. Early mowing will reduce the effectiveness of growth retardant treatment.

## **TREES & BRUSH**

**USES: MAINTAIN CF 125,** applied to the foliage, effectively retards the growth of most trees and brush.

**WHERE TO USE:** On trees and brush growing under utility lines, as screens or ground cover adjacent to highways, in hedge rows and parks.

**WHEN TO USE:** A foliage spray should be made after a flush of growth or after pruning and the new leaves have fully developed so that the plant has the desired density, size and shape. Tender new growth may curl or twist. Flowering species treated before bud expansion may have a blossom reduction.

MAINTAIN CF 125 will effectively retard woody plant growth for two months and up to a

year or more on deciduous hardwoods.

Gymnosperms (conifers, etc.) must be treated before buds expand in order to prevent distortion of new growth. Treatment when candles are tender often causes developing branches to droop.
