DIRECTIONS: DELLA-DAIRY SPRAY Barn and Livestock Spray kills Face Flies, Horn Flies, Stable Flies, House Flies, Mosquitoes and Gnats.

This solution is a dual purpose formulation. It is designed for use as a spray to protect dairy and beef cattle, poultry, hogs, and horses from the attack of biting flies. It is also a very effective space spray and will provide fast knockdown and kill of house and other flies in the barn, poultry buildings, milk room, dairies, feed lots and piggeries.

FOR USE AS AN ANIMAL SPRAY: Apply as a fine mist. Use only enough to wet the ends of the hair but not enough to wet the skin. Apply at a rate of 28-58 grams per adult cow or horse. Do not apply to udders of milking cows. On hogs, spray over back, side and belly, where flies congregate. Repeat at daily intervals or as necessary, to give continued protection. Do not

wet skin. Do not use more often than once a day. Take care not to spray in animal's eyes or mouth. Do not cover horses after treating.

FOR USE AS A SPACE SPRAY: May be used in hand sprayers, mist foggers or thermal foggers. To clear areas of flies, mosquitoes, and gnats, direct spray toward the ceilings and corners until the area is filled with a light mist. Insects must be contacted to be killed. For best results, close all windows and doors during spraying and keep them closed for 10 - 15 minutes after spraying.

Remove animals at time of spraying. Ensure proper ventilation after sealed areas have been treated. Allow area to ventilate one hour before animals re-enter. Use 200-300 mL of solution per 100 m³. Sweep up dead insects. Repeat as necessary with additional spraying of breeding areas. Spray only when temperature is under 32°C.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN-NOT FOR USE ON HUMANS. Product contains petroleum distillate. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled or absorbed through the skin. Wash thoroughly with soap and water after handling and before eating or smoking. Do not contaminate feed, water or foodstuffs. Protect milk and milking utensils from the spray. Any treated surface that may contact food or feed products should be washed thoroughly with potable water after spraying and before re-use. Do not store or spray near an open flame. Do not use in area where bee-keeping equipment or supplies are stored. Product is toxic to fish. Do not contaminate any body of water.

FIRST AID: If on skin, wash thoroughly with soap and water. If sprayed in eyes, flush with clean water. If irritation persists, obtain medical attention at once. Contains petroleum distillates. If swallowed, DO NOT induce vomiting. Get medical attention immediately.

TOXICOLOGY: Dichlorvos is a cholinesterase inhibitor; atropine is antidotal. In case of accidental poisoning seek medical attention; take label or empty container to attending physician.

DISPOSAL: Do not re-use empty container. Follow provincial instructions for any required cleaning of the container prior to its disposal. Make the empty container unsuitable for use and dispose in accordance with provincial requirements. For information on the disposal of unused, unwanted product, and the cleanup of spills, contact the regional office of Conservation and Protection, Environment Canada.
