DIRECTIONS: Place blocks in inaccessible locations in areas such as along walls, in corners, near rat holes, and in concealed areas where rats and mice feed, water or travel. Check daily to make sure that an uninterrupted supply of bait is available for at least 15 days. Continue baiting until all signs of feeding have stopped. Rats: break and place 4 to 16 blocks 6 to 9 m apart. Mice: Break and place single blocks 2 to 3 m apart. For Burrow Application, place one or two pieces per burrow.

To prevent reinfestation, eliminate food, water and harbourage. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

In meat packing and food processing plants, use only when plant is not in operation. Remove or cover all food, packaging materials and utensils before placing baits. Remove all baits and dead rodents before reuse of plant for food processing.

PRECAUTIONS: Keep bait away from human beings, domestic animals and pets. Do not contaminate feed or food. Burn or bury bodies of dead rodents. Do not contaminate any body of water. Discard empty containers in household garbage.

FIRST AID: If swallowed, give patient one or two glasses of water and cause vomiting by inserting a finger down the throat. Repeat until vomit fluid is clear. Call a physician immediately.

TOXICOLOGICAL INFORMATION: If swallowed, chemical reduces clotting ability of the blood and may cause internal bleeding. Intravenous and oral administration of vitamin K1 combined with blood transfusions are indicated, as in the case of haemorrhage caused by overdoses of dicumarol.
