DIRECTIONS FOR USE:

This product is a finely divided powder which combines the flushing and killing powers of pyrethrins and piperonyl butoxide. It is relatively odourless and non-staining and may be used in accordance to directions in homes, restaurants, stores, hotels, offices, plants, warehouses, truck trailers and railroad cars. When used as directed, it is effective in controlling such insects as ants, roaches, silverfish, bedbugs, fleas and lice.

APPLICATION WITH FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS:

Food processing plants and warehouses, bakeries, beverage plants, restaurants, hotels, hospitals and schools:

Limited to crack and crevice treatment only. Using a bulbous duster apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housings, junction boxes, or switch boxes, conduits

or hollow equipment legs where roaches, ants, silverfish, spiders, and crickets hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces. APPLICATION OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.

#### CAUTION:

In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food processing.

#### NON-FOOD AREAS:

Homes, institutions, hospitals, office buildings, hotels, motels, theatres, schools, truck trailers and railroad cars:

To control such running and crawling insects as ants, cockroaches, silverfish, and fleas in animal quarters, distribute Drione at a rate of 60 grams per 10 square meters of surface area. Apply as a continuous visible film underneath and behind stoves, refrigerators, and appliances. Treat on, around and behind moulding, shelving, baseboards, pipe openings, cracks, crevices and other areas where insects may hide. For severe infestation, apply Drione behind cabinets and walls, in crawl spaces and attics at the rate of 500 grams per 100 square meters of surface area. Repeat treatment as necessary.

#### BEDBUGS:

Take bed apart. Dust joints and channels. If hollow such as square or round tubing, see that the interior of framework is well dusted. The mattress should be dusted especially tufts, folds and edges. Picture frame mouldings and all cracks and crevices in the room should be treated.

#### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. avoid contact with skin and avoid inhaling powder. This product is toxic to fish. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not contaminate food, feed or food processing equipment. Thoroughly wash with potable water all treated food preparation

surfaces and food processing equipment.

FIRST AID:

External contact, wash with soap and water. If in eyes, flush with plenty of water. If swallowed, do not induce vomiting. If patient is unconscious, give him air. Get prompt medical attention.

DISPOSAL:

Do not re-use empty container. Dispose of with regular garbage.
