## DIRECTIONS FOR USE

1) Cooling Tower Systems: Prior to use in water cooling towers, systems should be cleaned to remove organic, inorganic and microbiological deposits. An initial slug addition of 500 -1000 mL per 10,000 liters of water should then be added to the sump of the cooling water towers. Repeat the initial dosage until control is evident. Subsequent slug additions of 200 to 1000 mL per 10,000 liters of water should be added every 2 to 5 days or as needed. The frequency of addition will depend on the relative amount of bleedoff and the severity of the microbiological problem.
