DIRECTIONS: Before adding PRO CHLOR, the pH should be tested and adjusted to within 7.2 to 7.6. Add muriatic acid if pH is high. Add soda ash if pH is low. PRO CHLOR should be added daily to maintain 0.6 to 1.0 parts per million available chlorine. The use of test kit is recommended, as the air temperature and the number of people in the pool will affect the amount of PRO CHLOR required. Under average conditions PRO CHLOR should be added daily to pool water according to the following chlorination guide.

Pool Capacity(Litres)	Daily Charge(Litres)
10,000	125-250 mL
20,000	325-625 m
50,000	625 mL-1.25 L
100,000	1.25 L-2.50 L
250,000	3.25 L-6.25 L

Note: First application should be double the indicated amount. Every three weeks, add one week's charge of PRO CHLOR in one application to ensure proper control of algae, slime and fungus. Avoid using pool until chlorine residual drops below 2.0 p.m.m. (approximately 24 hrs.).

FOR SANITARY SWIMMING & WADING POOL WATER : Add the correct amount of PRO CHLOR to the water daily. For wading pools add 5

mL PRO CHLOR for every 250 L of water pools add 5 mL PRO CHLOR for every 250 L of water daily. PRO CHLOR is recommended for use in all types of pools: vinyl lined, concrete and fibre glass.

CAUTION: KEEP OUT OF THE REACH OF CHILDREN. NEVER MIX WITH OTHER POOL OR HOUSEHOLD CHEMICALS. Do not mix with a toilet bowl cleaner, rust removers. Avoid contact with skin and eyes.
