used on vessels in both salt and fresh water.

Stir paint thoroughly before applying. TFA-10 A may be applied by spray, brush or roller. Airless spray is strongly recommended if spray is chosen. The surface should be clean and dry prior to paint application. A suitable anticorrosive coating should be applied to metals, and a primer is recommended for wood and fiberglass. Allow a minimum of 12 hours before returning vessel to water.

Large vessels, i.e. over 25 M, must be treated by trained applicators.
