DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the *PEST CONTROL PRODUCTS ACT*, or a fertilizer-pesticide registered under the *FERTILIZERS ACT*.

LIMITATION:

Do not apply directly as is to crops.

PRECAUTIONS:

KEEP OUT OF THE REACH UNAUTHORIZED PERSONNEL.

Avoid contact with eyes, skin and clothing. Harmful if swallowed. May cause eye or skin irritation. Do not inhale vapours. Wash well after handling and before eating, drinking or smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes.

STORAGE:

1. Keep in original container during storage.

In case of skin contact: Wash with plenty of soap and water. Consult a physician if irritation develops.
