USE DIRECTIONS

To prevent the establishment of weeds on industrial sites such as utility substations, pipelines and tank farms.

Site preparation:

For best results, remove all remnants of existing vegetation or unwanted plant growth. Rake and smooth the soil before installing the fabric.

Installation of the geotextile fabric:

Simply unroll the material to the desired length and cut using scissors. When overlapping is necessary, we suggest a 10-15 cm (4 to 6 inch) overlap. It is recommended to clean the TEX-R PRO thoroughly before covering it with any material. The glazed surface of the fabric must be upward and should not be installed facing the ground.

Covering the geotextile fabric:

Cover Tex-R PRO geotextile fabric completely with a 2.5-5 cm (1-2 inch) layer of "sterile" material to protect it against the sun.

PRECAUTIONS:

Wear gloves when handling fabric. Avoid contact with skin and eyes. Keep out of any body of water; toxic to fish.

FIRST AID:

Skin contact: Wash with plenty of soap and water.

Eye contact: Hold eyelids open and flush with water until no evidence of Chemical remains (at least 15 minutes). Get medical attention.

In case of accidental poisoning, get medical attention or contact a poison control centre. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
