SPACE SPRAY: Kills flying insects in milking parlors, milkhouses  
and barns. Direct spray upwards to all parts of the room

especially windows and other light sources. Apply at a rate of 1 to 2 seconds per 30m3. Remove all animals from barn before using as a spray. For best results, close all doors and windows during treatment. Ventilate treated areas thoroughly for at least 30 minutes before letting the animals reenter. Spray only when temperature is under 32'C.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.

Do not remain in treated areas. Ensure proper ventilation after sealed areas have been treated. Cover milk and milking utensils to prevent contamination from spray and dead insects, do not spray milk or milking equipment (any treated surface that may contact food or feed products should be washed thoroughly with potable water after spraying and before reuse). Do not contaminate food, feed or water troughs. Avoid inhalation of spray. Avoid contact with skin and eyes. Wash after using.
