LONZA FORMULATION S-18-8 is an effective one-step sanitizercleaner for use on non-food contact surfaces.

When used as directed, LONZA FORMULATION S-18-8 will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas and other places where bacterial growth can cause malodors.

## PRECAUTIONARY STATEMENTS:

FIRST-AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

## DIRECTIONS FOR USE:

LONZA FORMULATION S-18-8 is a proven "one-step" disinfectant-cleaner-sanitizer-fungicide-mildewstat-virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply LONZA FORMULATION S-18-8 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, or mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION - to disinfect hard, non-porous surfaces, add 8 mL/L of water. Treated surfaces must remain wet for 10 minutes. At this use level, LONZA FORMULATION S-18-8 is also virucidal and fungicidal.

SANITIZING - to sanitize non-porous, non-food contact surfaces, add 1.5 mL/L of water. Treated surfaces must remain wet for 60 seconds.

8 mL/L Use-Level: The broad spectrum activity of LONZA FORMULATION S-18-8 has been evaluated and found to be effective against the following organisms by the AOAC Use Dilution test:

Pseudomonas aeruginosa Salmonella choleraesuis Streptococcus pyogenes Enterobacter aerogenes Streptococcus faecalis Brevibacterium ammoniagenes Staphylococcus aureus Escherichia coli Klebsiella pneumoniae Salmonella schottmuelleri Shigella dysenteriae Salmonella typhi AOAC Fungicidal Test: LONZA FORMULATION S-18-8 is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc.

Disposal of Infectious Materials: Blood, body fluids, cleaning materials and clothing should be autoclaved and disposed of according to provincial and local regulations for infectious waste disposal.
