FOR MANUFACTURING USE:

As an in-can preservative in water-based paints and coatings and as a fungicide in water-based paints and coatings used for exterior applications. Do not use in paints containing lithopone-effectiveness destroyed by sulfide pigments. Do not use as a fungicide in water-based paints for interior applications.

NOTE: Products containing this additive are not to be used in areas where food is stored, handled or processed. Do not use in greenhouse paints and marine antifouling paints.

DIRECTIONS FOR USE:

- A. For PACKAGE STABILITY of most aqueous systems including paints and the protection of CARBOHYDRATE type thickener solutions use 125 250 grams COSAN PMA-100 WSB per 1000 litres.
- B. For all PROTEIN colloids and systems containing protein colloids, use 250 500 grams of COSAN PMA-100 WSB per 1000

litres.

C. For MILDEW RESISTANCE of most dry films, use 1 kg to 3kg of COSAN PMA-100 WSB per 1000 litres.

In the finished paint, when the mildew resistance level of COSAN PMA-100 WSB is used, can stability is automatically assured.
