KILLS: Dandelions, Plantains, Chickweed, Clover, Bedstraw, Black Medick, English Daisy, Curled Dock, Heal-all, Ground Ivy (Creeping Charlie), Knotweed, Ragweed, Shepherd's-Purse, plus over 35 other lawn weeds.

DIRECTIONS: Turn adjustable nozzle in direction of arrow. Squeeze trigger to operate. Adjust nozzle to provide desired spray pattern. Apply when weeds are actively growing. Do not water for 24 hours. Rain within 6 hours reduces effectiveness.

Adjust nozzle to give coarse, wet stream. Aim at weed; pull trigger. Only short burst necessary. Spray acts within a few days and weeds gradually die. Grass fills in as weeds disappear. Some weeds may require up to 4 weeks for complete kill. Repeat in 3-4 weeks if necessary. For numerous weeds, spray overall with SUPER WEED-B-GON® LIQUID.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful to some desirable plants. Avoid spraying flowers, shrubs, vegetable and fruit crops. Bent grass may be injured. Do not store near seeds, fertilizers, insecticides or fungicides. Keep from freezing.

Protective Clothing:

Wear long-sleeved shirt, long pants, socks and shoes.

Operator Use Precautions:

Wash hands before eating, drinking, using tobacco or using the toilet.

After treating, wash thoroughly.

If pesticide penetrates clothing, remove immediately; then wash contaminated skin thoroughly and shower. Launder contaminated clothing separately before reuse.

Re-entry Interval:

Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treated areas until spray has thoroughly dried.

FIRST AID:

If on skin, remove contaminated clothing and wash skin with soap and water. If in eyes, flush with plenty of water. Obtain medical attention. If swallowed, rinse mouth with water. Drink water to dilute. Call doctor or Poison Control Centre if symptoms of poisoning occur.

DISPOSAL:

Do not reuse empty container. Dispose of empty container in household garbage.
