DIRECTIONS FOR USE:

WIPE-ON METHOD FOR HORSES: Apply with a cloth which is slightly moistened with the product. Avoid eyes and mouth. Use 30-60 mL for an adult horse. Repeat daily or as necessary. SPRAY FOR HORSE STABLES: Remove all animals before using as a space spray. Close doors and windows. Wear mask or respirator and protective clothing. Use a spraying device such as a Fogmister or use U.L.V. equipment which dispenses a fine mist with droplets 15-20 microns in diameter. Direct spray upwards to all parts of the room, especially windows and other light sources. Use 200-300 mL of solution per 100 cu. meters. Leave the room closed for 15 minutes before ventilating. Do not use in dwellings. Ventilate and keep livestock out of sprayed/treated area for at least 30 minutes after treatment. Spray only when temperature is under 32 deg C. Do not use in milking parlor areas.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not remain in treated areas. Ensure proper ventilation after sealed areas have been treated. Avoid inhalation of spray. Avoid contact with skin and eyes. Harmful if swallowed, inhaled or absorbed through skin. Wash after using. Wash contaminated clothing before reuse. Do not contaminate feed, food or litter. Do not contaminate food-handling equipment. Store in original container away from feed and food. Do not contaminate any body of water. Highly toxic to crabs, fish and shrimp. Harmful to wildlife if allowed to contaminate lakes and streams. Do not apply fog within 8 hours to areas where livestock have received treatment. When fogging indoor areas, evacuate all animals and isolate area. Ventilate thoroughly before re-admitting animals. Do not use in areas where beekeeping equipment or supplies are stored, or where milk is stored or processed.
