A premium grade ready to use insecticide solution for use in thermal foggers for the outdoor control of mosquitoes, blackflies, gnats, and other small flying insects outdoors or in evacuated farm buildings.

DIRECTIONS:

For most effective treatment apply a dense fog close to the ground at the rate of 100 mL per 100 square m. Fogging should be done early morning or late evening when the air is calm. When using a thermal fog generator, the equipment must be operated and maintained in the manner prescribed in the instructions given in the manufacturer's manual. Repeat treatment during the season as often as necessary to control adult biting insects.

PRECAUTIONS:

Avoid inhaling spray mist. Avoid contact with skin, eyes and clothing. Avoid contamination of feed and food. Do not contaminate mangers, drinking troughs or utensils. Wash after handling or using. Avoid contamination of ponds, lakes, streams and other bodies of water which contain fish life or which may be used for irrigation or domestic purposes. Care should be taken

in disposing of empty containers. Keep out of reach of children. Do not fog food crops. Keep away from fire or other sources of heat. Do not fog into open flame.

FIRST AID:

For external contact, wash with soap and water. If in eyes, flush with plenty of water. If swallowed, cause vomiting and obtain medical attention.

TOXICOLOGY:

Malathion may cause cholinesterase inhibition. Atropine is antidotal.
