DIRECTIONS FOR USE:

Apply LONZA FORMULATION S-37-3 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, tile, porcelain, sinks and bedframes with a cloth, or mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION: To disinfect hard, non-porous surfaces add 8 mL/L of water. Treated surfaces must remain wet for 10 minutes. At this use level, LONZA FORMULATION S-37-3 is also virucidal and fungicidal.
