HICHLON JUMBO TABLETS (200 GM) ARE TO BE USED ONLY IN WASTEWATER TABLETS CHLORINATORS DESIGNED TO ACCEPT 6.7 CM DIAMETER TABLETS.

TO FILL THE CHLORINATOR, REMOVE THE TUBES AND FILL AS FOLLOWS:

- 1. REMOVE CAPS AND RINSE TUBES WITH WATER;
- 2. FILL EACH TUBE TO TOP, ADDING ONE TABLET AT A TIME;
- 3. TABLETS MUST LAY FLAT OR TUBES WILL CLOG;
- 4. REPLACE CAPS AND INSTALL TUBES SO THEY REST IN CHANNEL IN FLOOR OF CHLORINATOR.
- 5. ADJUST CHLORINATOR TO PRODUCE 0.5 TO 2.0 PPM AVAILABLE CHLORINE IN WASTEWATER.

STORAGE:

- 1. KEEP THIS PRODUCT DRY IN A TIGHTLY CLOSED CONTAINER, WHEN NOT IN USE.
- 2. STORE IN COOL DRY WELL VENTILATED AREA AWAY FROM HEAT OR OPEN FLAME.
- 3. IN CASE OF DECOMPOSITION, ISOLATE CONTAINER IF POSSIBLE, AND FLOOD THE AREA WITH LARGE AMOUNTS OF WATER TO DISSOLVE ALL MATERIALS BEFORE DISCARDING THE CONTAINER.
