FECTANT-3 Germicidal Cleaner is recommended for the cleaning, sanitizing, deodorizing and disinfecting of floors, walls, ceilings, fixtures and other environmental surfaces in hospitals, industrial plants, schools, municipal buildings, hotels and motels.

FECTANT-3 Germicidal Cleaner is free rinsing and leaves no soap scum.

FECTANT-3 Germicidal Cleaner is an effective disinfectant and deodorizer when diluted 15 mL per litre of water. When used at this dilution, it reduces the hazard of Staphylococcus aureus as well as certain other pathogenic micro-organisms on environmental surfaces such as floors, walls and other hard surfaces.

FECTANT-3 Germicidal Cleaner has a phenol coefficient of 13.0 against Staphylococcus aureus and 10.0 against Salmonella typhosa. For effectiveness against Pseudomonas aeruginosa, a 30 mL per litre dilution of FECTANT-3 must be used.

FECTANT-3 Germicidal Cleaner is an effective fungistat and will control mildew and mold on floors, walls and ceilings. Clean these surfaces prior to application with a compatible detergent using a scrub brush if necessary. Mix 30 mL per litre of water and apply to the surfaces to thoroughly moisten all areas. May be sprayed or mop applied. Repeat application in 7 days to maintain control.

FECTANT-3 Germicidal Cleaner can also be used in sanitizing food contact surfaces on food processing, meat packaging and dairy equipment. When used for this purpose, limit the level of active quaternary to 200 ppm by diluting 6 mL of FECTANT-3 Germicidal Cleaner to one litre of water. All surfaces subject to food contact must be thoroughly rinsed with water of potable quality following use of this product.

NOTICE TO USER: This control product is to be used only in accordance with the directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions.

DIRECTIONS FOR USE: Remove gross filth and heavy soil deposits from surfaces prior to application of the recommended solution. For cleaning and disinfecting resilient floor surfaces or on sealed wood floors, dilute FECTANT-3 Germicidal Cleaner 15 mL per litre of water. Use 30-40 mL per litre of water if the floor is

extremely dirty. Apply with a clean mop so as to thoroughly wet floor. After the cleaner has loosened the dirt and soil, pick up the remainder with a mop, squeegee or wet pick-up vacuum. If desired, the floor may be rinsed with clean water. Walls and other hard surfaces should be cleaned and disinfected with the dilutions used for floors. Apply with a cloth or sponge. For mildew control, follow the directions above. For sanitizing food process, meat packing and dairy equipment, clean and rinse equipment thoroughly. Then apply a solution of 6 mL of FECTANT-3 Germicidal Cleaner per litre of water by flooding the surface, mopping or wiping on. Follow with potable water rinse.

NOTE: Do not reuse empty drum. Return to drum reconditioner or destroy by perforating and burying in a safe place.

PRECAUTIONS: Keep out of reach of children. Causes eye damage. Causes skin irritation. Do not get in eyes, on skin or clothing. Protect eyes when handling the concentrated product. Harmful if swallowed. Avoid contamination of food.

FIRST AID: If swallowed, drink large quantities of milk, raw egg whites, gelatin solution, or if these are not available drink large quantities of water. Call a physician. If on skin, flush with plenty of water for at least 15 minutes.

NOTICE: KEEP FROM FREEZING. If this product is stored in cold or freezing weather, it may separate or thicken. This will not harm the performance. Before using, warm to room temperature and stir thoroughly.
