DIRECTIONS FOR USE:

GENERAL DISINFECTION For disinfecting floors, wells, countertops, tables, chairs, garbage pails, bathroom fixtures and other hard surfaces, add 4 mL of Liquid Disinfectant to 1 litre of water. Apply to previously cleaned hard surfaces with mop or cloth.

DISINFECTION OF BARBER TOOLS: Precleaned barber tools (such as combs, brushes, razors, and scissors) can be disinfected by

immersing in a 4.0 mL/L solution of Liquid Disinfectant. Fresh solution should be prepared daily or when the solution becomes visibly dirty.

SANITATION OF HARD SURFACES AND EQUIPMENT: Wash and rinse all articles thoroughly, then apply a solution of 2 mL liquid Disinfectant in 1 litre of water (150 ppm active). Surfaces should remain wet for at least 1 minute followed by adequate draining and air drying. Fresh solution should be prepared daily or when used solution becomes visibly dirty. Apply to sink tops, countertops, and display equipment and other stationary hard surfaces by cloth or brush. No potable water rinse is required.
