How Impact works:
Impact will attract foraging worker ants to the bait feeding station.

Worker ants will take some of the bait back to the nest where they will pass it on to destroy the queen and the entire colony.

DIRECTIONS FOR USE:

1. Use all 3 bait stations. Separate bait stations from frame. Do not remove or puncture labels on bait stations. Peel off square backing to expose adhesive strip. Place bait stations near trails or where you frequently see ants. Place additional bait anywhere ants may enter your home.
2. For best results do not interfere with the ants or bait stations during use. Do not use insecticide sprays on or around the baits.
3. Replace all three bait stations every three months if needed to keep ants under control.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. PLACE BAIT STATIONS IN AREAS NOT ACCESSIBLE TO CHILDREN OR PETS. Avoid contamination of food and feed. Do not place directly over food, utensils, dishes or food preparation surfaces. Do not remove bait from stations. May be harmful if swallowed.

FIRST AID INSTRUCTIONS: If bait stations content is swallowed: Drink one or two glasses of water and induce vomiting by touching the back of the throat with a blunt object. Do not induce vomiting or give anything by mouth to an unconscious person. Call a physician or poison control centre.
