DIRECTIONS

Spray TRE-HOLD Spray paint on the pruning cut when the cuts are made.

SHAKE CAN WELL. Hold the can upright 25 to 50 cm, from the pruned surface and depress button. Thoroughly cover the pruned surface and

the bark around the cut.

For most effective control of resprouts, prune to a lateral branch (drop crotch pruning). Do not leave stubs (see illustrations) and avoid severe trimming. Treatment of all cuts is important.

Many trees sprout prolifically after they have been pruned. Periodic pruning to maintain line clearance is one of the major expenses of many public utilities. TRE-HOLD Spray Paint, in combination with proper pruning techniques, reduces the number of new sprouts on many tree species. This provides a longer periods before they must be trimmed again and reduces the number of sprouts for later trimming.
