DIRECTIONS FOR USE

DYRENE Lawn Fungicide gives effective control of Rhizoctonia brown patch, Sclerotinia dollar spot, copper spot, and Helminthosporium diseases, such as melting-out of Kentucky

bluegrass and Helminthosporium leaf spot of bluegrasses, bentgrasses, and fescues.

HOW TO USE:

In Garden Hose Sprayers: Add 175 g of DYRENE Lawn Fungicide to 475 mL of water and stir until a uniform mixture is obtained. Pour mixture into jar of garden hose sprayer. Do not add additional water. Apply spray mixture uniformly to 100 square metres of lawn area.

In Compressed Air Sprayers: For use in hand or knapsack-type sprayers, add 125 g of DYRENE Lawn Fungicide to 10 L of water and apply to 100 square metres of lawn or other turf area. For spot treatment of heavily diseased areas, add 175 g to 10 L of water and thoroughly wet these areas.

WHEN TO APPLY:

For Foliar Turfgrass Diseases: Begin applications in the spring before diseases appear and repeat at 10 to 14-day intervals. During extended periods of wet weather, applications every 7 days may be required. Continue treatments throughout the spring and summer months. If necessary, water the lawn before applying DYRENE Lawn Fungicide.

DANGER: Corrosive. Causes irreversible eye damage. Harmful if inhaled. DYRENE may cause an allergic skin reaction in some susceptible persons. The condition should be treated as an allergic dermatitis.

Wear goggles or safety glasses. Avoid breathing dust. Protective clothing and gloves should be worn during periods of of exposure such as handling of concentrate, mixing, loading and application or when contacting treated foliage. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reusing.

FIRST AID: In case of poisoning call a physician immediately. Have patient lie down and keep quiet. If swallowed, vomiting should be induced. Administer water freely and induce vomiting by giving one dose (15 mL) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. The patient should be lying down with the head below the foot level

and facing down or to one side. Professional medical assistance should be secured immediately. DO NOT INDUCE VOMITING TO AN UNCONSCIOUS PERSON OR TO PERSONS IN A CONVULSIVE STATE. If on skin, remove contaminated clothing and wash skin immediately with soap and warm water. If eyes are contaminated, wash immediately with flowing water for at least 15 minutes.

TOXICOLOGICAL INFORMATION: The exact toxic mode of action of DYRENE is not known. In experimental animals acutely poisoned with DYRENE no characteristic symptoms were noted. The patient should be treated symptomatically.

Do not contaminate feed, foodstuffs, water supplies, and fish ponds. Keep out of reach of children.

DISPOSAL of EMPTY CONTAINERS:

- 1. Do not reuse the container.
- 2. Completely empty the bag into application equipment and add the rinsings to the spray mixture in the tank.
- 3. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 4. Dispose of the empty bag in accordance with provincial requirements.
