To repel mosquitoes/black flies and block the sun, apply a thin uniform film to exposed skin areas avoiding eyes and mouth. Do not use under clothing. Repeat as needed only if exposure to mosquitoes/black flies continues. Frequent reapplication and saturation is unnecessary for effectiveness. Avoid overexposure. Wipe hands after use. After returning indoors, wash hands and treated skin with soap and water.
