INDOOR USE: ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SAWTOOTHED GRAIN BEETLES (EXPOSED STAGE). Spray int cracks, crevices, around baseboards, and other places where these insects hide. Also behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. For ants spray trails and places where ants enter premises. Repeat as needed.
