DIRECTIONS:

Shake well before using. Close doors and windows and other openings and remove all animals from buildings before application. Apply with a mist fogger (non-thermal) or manual pump at a rate of 200 mL per 100 m³. Wear a mask or respirator

and protective clothing. Apply to cracks, crevices and wall surfaces. Direct spray upwards, towards ceilings and walls or straight on insects. Keep area closed for 10-20 minutes after fogging. Ventilate thoroughly before re-entering treated areas. Repeat as necessary. Do not use in rooms where milk is processed, handled or stored. When using a mist fogger, the equipment must be maintained and operated in accordance with the manufacturer's instruction manual.

NOTE: Treatment should be made only before or after milking.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Not for use on animals or humans.

Apply only when the dairy is not in operation. Cover or remove all food processing surfaces, milk utensils, and dairy equipment.

Avoid contamination of feed and water troughs. After spraying, wash all surfaces that may contact milk food and rinse thoroughly with potable water before re-using. Thoroughly clean all food processing equipment with potable water before resuming operations. Avoid contact with skin. Do not inhale spray mist. Wash after using. Do not store near food water or litter. Keep in original container during storage. Store in a cool, well ventilated place. Do not use in areas where beekeeping equipment or supplies are being stored. Do not contaminate any body of water. Toxic to fish.

FIRST AID:

This product contains petroleum distillate; harmful if swallowed, inhaled or absorbed through skin. In case of poisoning, call a physician immediately. If on skin, remove contaminated clothing and wash skin thoroughly with soap and water. If in eyes, flush with water for 5-10 minutes and obtain medical attention. If swallowed, do not induce vomiting, but rush the patient to the nearest hospital or doctor's office, taking the pesticide container with you.

DISPOSAL:

Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further

use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection, Environment Canada.
