SPACE SPRAY

To kill flies, mosquitoes, gnats and flying moths: dilute 750 mL of INSECT-KURE concentrate with 18 litres of water (in case of dilution for packaging ready-to-use solutions, use distilled water or deionized water only). Mix thoroughly until a uniform clear emulsion forms. INSECT-KURE diluted concentrate can be used with a special automatic computerized U.L.V. fogging device or portable hand fogger. For heavy infestation set the system to deliver 300 mL per day for 2 days. After set the system to 75 mL for maintenance. If infestation repeats you may return to higher dosage 300 mL for maintenance. If infestation repeats you may return to higher dosage 300 mL per day for 2 days so on. Apply as a fog or fine mist directing spray upwards to all parts of the room.

#### USE AREAS

Hog, dairy and beef barns, horse stables, stables, dairies and other areas with at least 1350 cubic metres of free air space where flies, mosquitoes and gnats are an annoyance. For heavy infestation set the system or hand fogger to deliver 300 mL per day for 2 days. After set the system or use hand fogger to deliver 75 mL for maintenance. If infestation repeats you may return to higher dosage 300 mL per day for 2 days and so on. Remove all animals from treated area and do not remain in the room. Close doors and windows. Ventilate thoroughly for at least 30 minutes before animal reentry.

#### PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN

Flammable mixture. Product contains Petroleum distillate. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed. Avoid eye contact. In dairies, use only when plant is not in operation. Cover or remove all milk, milking implements, food, packaging materials and utensils before treatment. Any treated surface that may contact food should be washed thoroughly and rinsed with potable water before reuse. Remove pets, birds and cover fish aquariums before spraying. Keep container closed. Do not store, pour or spill near heat or open flame. Keep out of any body of water. Do not contaminate water when cleaning equipment, or disposal of water waste. Apply this product only as specified on this label. Do not pack diluted product in metallic containers or cans: brown glass bottles are preferred. This concentrate does not emulsify spontaneously: it must be agitated thoroughly.

#### DISPOSAL

Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to

its disposal. Make the empty container unsuitable for further use. Keep container closed when not in use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the clean up of spills, contact the regional office of Environmental Protection, Environment Canada.

#### FIRST AID

If concentrate is swallowed, do not induce vomiting due to risk of aspiration hazard from petroleum distillate. If diluted formulation ingested, try to induce vomiting by giving one or two glasses of water and tickling the back of the throat. Contact physician immediately. If in contact with eyes, rinse with water. If on skin, wash with soap and water. If irritation develops or persists, consult physician.
