DIRECTIONS: 15 mL = 1 tablespoon

1. Mix 15 mL of product per 2 L of water.
2. Spray 2 L evenly over 10 m².
3. Apply in late Spring or early Fall on actively growing weeds.
4. Avoid applications during long dry periods. Repeat as necessary.
5. Fertilize and water lawn after weeds are killed to fill any bare spots.

MAXIMUM APPLICATION FREQUENCY TO TURF: For good turf/lawn management, normally two applications per year per treatment site are adequate. This does not include spot treatments.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contacting skin, eyes and clothing. Wash hands after using. Do not store near seeds, fertilizers, insecticides or fungicides. Avoid spray drift onto susceptible plants. Spray injurious to many cultivated species. Do not apply when rain is expected. Do not water within 24 hours of spraying. Do not use on Bent grasses. Do not use same sprayer for other uses. Do not apply on newly seeded lawns until after third mowing.

PROTECTIVE CLOTHING: Wear long sleeved shirt, long pants, socks, shoes and chemical resistant (e.g. rubber) gloves.

OPERATOR USE PRECAUTIONS:

Rinse gloves before removal. Wash hands before eating, drinking, using tobacco or using the toilet. If pesticide penetrates clothing, remove immediately; then wash thoroughly and put on clean clothing. Remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water, then shower. Re-use gloves for pesticide application only.

RE-ENTRY INTERVAL: Do not allow people (other than applicator) or pets on treatment area during application. Do not enter treated areas until spray has thoroughly dried.

FIRST AID: IF SWALLOWED, induce vomiting. Obtain prompt medical attention or contact a poison control centre IMMEDIATELY. **IF IN EYES,** flush with clear water. **IF ON SKIN,** wash with soap and water. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not re-use empty container. Wrap in newspaper and dispose of empty container with household garbage.
