DIRECTIONS FOR USE:

HORSES AND PONIES

Repels and controls house flies, stable flies, horn flies, face flies, horse flies, deer flies, mosquitoes and biting midges. Kills fleas and ticks. Repels flies, mosquitoes and biting midges for 3 – 5 days.

INSTRUCTIONS: First, brush animal to remove excess dirt and dust. Rub towelette against hair growth. Apply around eyes, ears, nose and under belly. Avoid direct application to eyes and mouth. Only a light application is required. Do not wet skin, nor cover horses immediately after treatment. Do not apply to back of animal just before saddling. After application, brush thoroughly to bring out a bright sheen on the coat. Reapply as needed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contamination of feed and foodstuffs. HAZARDS TO HUMANS: May be harmful if absorbed through the skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling.

**HAZARDS TO ANIMALS:** Use on Show, Race, Work or Pleasure horses only. Do not use on horses intended for slaughter, nor on newborn or nursing foals.
