ORTHO TRIOX Granular Vegetation Killer is designed for quick
knockdown and control of general mixed vegetation on sidewalks,

driveways and patios, and may provide season long control of seedlings on treated areas. It will give quick knockdown of vegetation and residual control of broadleaved weeds and grasses on areas such as parking lots, fence lines, highway and railroad sites and industrial yards. DO NOT USE IN GARDENS, FLOWER BEDS OR ON LAWNS.

DIRECTIONS: ORTHO TRIOX Granular Vegetation killer can be applied dry from the shaker canister or as a liquid by dissolving the granules in water prior to application. Uniform application is necessary for both dry and liquid forms. Both dry and liquid applications become effective as soil treatments following rainfall or artificial watering.

DRY APPLICATION:

1. Distribute the contents of this canister evenly over 10 m² for the control of mixed vegetation.
2. Since the granules must be carried down into the soil before they become effective, the treated areas should be thoroughly watered after application.

LIQUID APPLICATION:

1. Dissolve the contents of canister in sufficient water to cover 10 m² for control of mixed vegetation. Stir thoroughly to be sure that all of the granules have dissolved.
2. To insure thorough coverage of weeds and grasses, apply material with a sprinkling can to 10 m² of area. Wash can thoroughly after use. Wet thoroughly all parts of the plants, particularly the growing tips.

PERSISTENT PERENNIAL WEEDS: Persistent perennial weeds are most effectively treated when nearing maturity or during dormant stages in the fall. Spring applications may also be made under moderate rainfall conditions. Summer applications are recommended only where rainfall is dependable for leaching the herbicide into the soil. Apply contents of canister to 5 m² for control of persistent perennials.

IMPORTANT: ORTHO TRIOX Granular Vegetation Killer is a nonselective weed killer and is toxic to all vegetation. Confine the treatment to the area where the plants are to be killed or the area rendered totally or partially unproductive for 1 or more years. Avoid contact with lawns, perennials, and other desirable plants. Avoid treatment of soil over roots of desirable plants, such as trees, shrubs and vines. Do not treat areas where run-off may injure desirable plants and lawns.

CAUTION: Harmful if taken internally. May cause irritation of eyes, nose, throat and skin. Avoid breathing dust or spray mist. Avoid contact with skin, eyes and clothing. Avoid contamination

of feed or foodstuffs. Wash clothing and equipment after application. Keep out of reach of children and pets.
