# LAWNS

Application at the recommended rate may be repeated as necessary.

White Grubs, Japanese Beetle Larvae, European Chafer Grubs: Apply 1.5 kg per 100 square meters of lawn. Water grass thoroughly after application. For Grub control apply any time between late July and early October.

Ants, Brown Dog Ticks, Chiggers, Chinchbugs, Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sod Webworm (Lawn Moths), Sowbugs, Springtails: Apply 200 gms per 10 square meters. Do NOT water for 2 days after application.

Leatherjackets: Apply 750 gms per 100 square meters. Water

thoroughly after application. Apply in late Fall while still mild, or first mild weather in Spring. Do NOT apply when soil is frozen.

#### SPOT TREATMENT

Ants: As a spot treatment apply 3 gms (1 teaspoon) of granules over and around each individual Ant hill.

Digger (ground) Wasps: Apply 3 gms (1 teaspoon) of granules over and around each nest opening; apply at dusk or at dawn when Wasps are not active.
