Easy-off Flea Killer contains residuals and is formulated for spot treatment of Carpets and Broadloom. Spray affected areas as needed. Repeat application if infestation is evident.

DIRECTIONS: Shake can well. Hold can in inverted position approximately 30 cm from surface to be sprayed. Test an inconspicuous area of carpet for colour fastness. Apply evenly and spray until wet. Spot treat carpets where pests may be present. Provide adequate ventilation.

DO NOT SPRAY PETS WITH THIS PRODUCT.
DO NOT USE AS A SPACE SPRAY.
KEEP CHILDREN AND PETS AWAY FROM SURFACE UNTIL DRY.
