DIRECTIONS: First application should be made when pool is being filled and before algae has formed. Use at the rate of 500 mL of ALGA-SAN in each 10,000 L of pool capacity. Pour ALGA-SAN directly into pool.

IMPORTANT: Avoid necessity of a cleaning problem by using ALGA-SAN when pool is being filled first time.

For subsequent treatment add 200 mL of ALGA-SAN to each 10,000 L of pool water every five to seven days. In cool weather, use less often - more often in warm, sunny weather.
