**DIRECTIONS:**

LIQUID ROTENONE is a general garden organic insecticide spray recommended for vegetable crops. It can be safely used on fruit and vegetable crops up to 1 day before harvest. It is also effective against chewing and sucking pests of ornamentals and flowers.

<u>Ornamentals and Flowers:</u> Gladioli, roses, zinnias, shrubs and trees	Aphids, canker-worms, flea beetles, tent caterpillars, thrips, as well as other insects listed.				
<u>Limitation:</u> Do not apply later than 1 day before harvest.					

\* The GREEN CROSS DIAL-A-SPRAY® is a hose-end sprayer with various settings. The number of the setting is the number of mL of product being applied per litre of water. Please refer to the DIAL-A-SPRAY label and pamphlet for use instructions.
