Allow hair coat to dry before brushing or combing. Repeat treatment as necessary, but not more often than once in two days. Thoroughly spray interior of kennel or other sleeping quarters.

For effective flea and tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

GROOMS: Conditions coat with lanolin.

DEODORIZES: Imparts a pleasing residual aroma.

STORAGE: Store in closed container in a cool, dry area.

DISPOSAL: Do not reuse empty container. Wrap container and put in garbage collection.
