### DIRECTIONS FOR USE:

QUAT DETERGENT S1 is a proven one-step disinfectant - cleaner - sanitizer - fungicide - mildewstat - virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination. Apply QUAT DETERGENT S1 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth or mop so as to thoroughly wet surfaces.

DISINFECTION: Add 35mL of QUAT DETERGENT S1 per 1 litre of water. Apply with mop, cloth or sponge, ensuring surface is thoroughly wet and remains wet for 10 minutes. Let air dry. For hospitals 50mL of QUAT DETERGENT S1 per 1 litre of water should be used. For heavily soiled areas, a pre-cleaning step is required. Prepare a fresh solution per each application.

MILDEWSTAT: Add 25mL of QUAT DETERGENT S1 per 1 litre of water. Apply with cloth, mop or sponge making sure surfaces are wet. Let air dry. Prepare fresh solutions for each use. Repeat application as necessary.

SANITIZATION: Prepare a 200 ppm active quaternary of 13mL of QUAT DETERGENT S1 per 1 litre of water. Make sure surfaces remain wet for 60 seconds.

INSTRUCTIONS FOR CLEANING AND DECONTAMINATING AGAINST HIV-1 ON SURFACES AND OBJECTS SOILED WITH BLOOD OR BODILY FLUIDS:

This product is effective against HIV-1 (Human Immunodeficiency Virus) in hard water up to 400 ppm (CaCO<sub>3</sub>), and in the presence of organic soil (5% blood serum).

Personal Protection: When handling items soiled with blood or bodily fluids, wear disposable latex gloves, gowns, masks, and eye coverings.

Cleaning Procedure: Thoroughly clean blood or bodily fluids from surfaces before applying "QUAT DETERGENT S1".

Contact Time: To kill HIV-1, apply "QUAT DETERGENT S1" 35mL per 1 litre of water and allow surface to remain wet for 2 minutes.

Disposal of Infectious Materials: Blood, body fluids, cleaning materials and clothing should be autoclaved and disposed of according to provincial and local regulations for infectious waste disposal.
