MUSHROOM FLY DUST is prepared for the control of mushroom phorid and sciarid flies. Use a good dusting machine to give better coverage. It is important that this chemical should be dusted immediately after flies appear. Houses should be as dry as possible, the door closed, and the air temperature up to 15'C. Repeat about once a week or as required. Do not pick within 48 hours after treatment.
