GARDEN CROPS: Use 30 - 90 mL (2 - 6 tbsp.) in 10 L of water to cover 100 m^2 on the following:

BEANS: Bean leaf beetles, Bean weevils, Leafhoppers, Mexican bean beetles.

BEETS, CARROTS, EGGPLANTS, LETTUCE, PEPPERS, RADISHES, SPINACH, TURNIPS: Blister beetles, Flea beetles, Leafhoppers.

BROCCOLI, BRUSSEL SPROUTS, CABBAGE, CAULIFLOWER: Cabbage loopers, Flea beetles.

CUCUMBERS, PUMPKINS, SQUASH: Cucumber beetles, Flea beetles, Leafhoppers.

ONIONS: Thrips.

PEAS: Pea weevils.

POTATOES: Blister beetles, Colorado potato beetles, Flea beetles, Leafhoppers.

TOMATOES: Blister beetles, Fall armyworms, Flea beetles, Tomato fruitworms.

ASPARAGUS: Asparagus beetles: 35-85 mL in 10 L of water to cover 100 m². Amount to be used depends on the size of the crop plants.

NOTE: Use with caution on cucurbits. Do not use on young Lima bean plants. Do not feed treated crops or crop refuse to animals. Do not apply within the specified days of harvest:

1 day - cucumber, eggplants, peppers, pumpkins, squash, tomatoes. 3 days - asparagus, cabbage. 7 days - beans, beets, cauliflower, onions, peas, potatoes, radishes, turnips. 14 days - broccoli, Brussels sprouts, lettuce, spinach.

May be used on carrots or turnips within 1 day if tops are not to be used for food or feed.

TREE FRUITS: APPLES, APRICOTS, CHERRIES, PEACHES, PEARS, PLUMS: Cherry fruit flies, Plum curculios - Use 40 - 80 mL in 10 L of water and spray thoroughly to cover all foliage and fruit. Start spraying at petal fall and use 2 - 3 applications at 7 to 14 day intervals as needed. Do not spray during bloom. Do not apply within the following pre- harvest intervals:

7 days - apples, cherries, pears, plums 21 days - apricots, peaches BRUCE SPANWORMS & WINTER MOTHS ON TREE FRUITS & ORNAMENTAL TREES (B.C. only): Mix 40 mL per 10 L of water and spray trees thoroughly. Apply in the spring at the time when blossom buds on the trees are in the pre-pink stage (before blossom). Use a second spray after blossom time if required. For best results follow provincial recommendations for timing.

SMALL FRUITS: CURRANTS, GOOSEBERRIES, STRAWBERRIES: Currant fruit flies, Strawberry weevils - Mix 40 - 80 mL with 10 L of water. Do not spray during bloom. Do not apply within 14 days of harvest.

FLOWERS, HOUSE PLANTS, ORNAMENTALS, SHRUBS, and TREES: Caterpillars, Elm leaf beetles, Flea beetles, Lace bugs, Leafhoppers, May beetles, Rose chafers, Rose leaf beetles, Rose slugs, Tent caterpillars, Thrips, Webworms, Weevils - Add 4 mL to 1 L of water to make a 0.1% solution. Apply sufficient spray to cover the plant thoroughly.

BACKYARDS, PATIOS: Ants, Centipedes, Crickets, Flies, Gnats, Hornets, Mosquitoes, flying Moths, Wasps - Use a 3% solution by mixing 120 mL of Methoxychlor 25% E.C. with 1 L of water. For flying insects, allow to drift over the area being treated. Repeat as necessary. For crawling insects, spray on surface or contact them directly with the spray. Spray directly on ant hills.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid inhaling the spray mist. Avoid contact with skin, eyes, and clothing. Wash after handling or using. Avoid contamination of feed and food. Avoid contamination of ponds, streams, and other bodies of water which may be used for irrigation or domestic purposes.
