COOLING WATER SYSTEMS: For the control of algae, bacteria, and fungi in commercial and industrial cooling water systems, add this product as follows:

Initial dose: 20-120 ml per 1,000 L water in the system.

Maintenance dose: Every 1 to 5 days or as needed, 6.4 to 40 mL per 1,000 L of water in the system.
