**DIRECTIONS FOR USE:** For exterior use. ROZ-TOX Preservative is a highly effective, ready-to-use solution that protects wood, rope or fabric against rot, mildew and termites. Use above ground only. ROZ-TOX Preservative will not bleed through if painted over. This product also increases the life of your wood.

**PENETRATING & PERMANENT:** Will not evaporate or wash out.

**ECONOMICAL:** Four litres treats 8-36 m<sup>2</sup> of wood, or 8-16 m<sup>2</sup> of 240g duck, or 16-28 kg of rope.

**USE EXACTLY AS RECEIVED:** When treating wood, make sure surface is clean and dry. Remove all paint, varnish, wax or any other coating that may impede penetration. No thinning is necessary.

APPLY BY BRUSH, SPRAY OR DIP: Apply as much solution as will readily soak up. The effectiveness of the preservative is determined by the penetration, so apply liberally. One coat is usually sufficient, but two coats are desirable if rotting conditions are severe. Wait six hours before applying a second coat. Allow 48 hours to dry before painting.

DIP METHOD: Immerse wood completely for 3-10 minutes per 2 cm of thickness. Dressed lumber: Dip 15-30 minutes per 2 cm of thickness. Treat ends thoroughly.

ON ROPE: Dip in solution for at least 1 minute, or longer depending on the diameter of the rope. Allow 12 hours for drying before using.

ON FABRIC: Dip in solution or saturate with a swab, sponge or brush. Drain and allow to dry before using.

CAUTION: Do not use on rubber-lined fabrics.

PRECAUTIONS: Keep out of reach of children. Avoid contact with skin and eyes. Use in a well-ventilated place. Wear suitable mask and protective clothing when applying by spray. After using, wash thoroughly before eating or smoking. Keep food and animals away from treated timbers. Toxic if swallowed. May irritate the skin. Poisonous to plants.

TOXICOLOGY: Contains petroleum distillate and zinc naphthenate.

FIRST AID: If swallowed, do not induce vomiting. Call physician immediately. If patient is unconscious, give him air.
