DIRECTIONS FOR USE: USE ONLY AS DIRECTED ON THIS LABEL

General: BUGCON ZEP BUG BUSTER PLUS: Residual Insecticide Contact Spray, as a spot or a crack and crevice treatment to control cockroaches, silverfish, ticks, fleas, and other insects listed below. Apply this product as a coarse spray to localized areas where pests are found or may occur. Spray surfaces until wet. Do not use as a space spray.

FOR SPOT TREATMENT to Kill Cockroaches, Ants, Crickets, Silverfish, Spiders, Earwigs and Sowbugs: Direct spray into areas where these pests are found or may hide; thoroughly treat cracks and crevices in walls; along baseboards and doors and window frames; behind and beneath sinks, stoves, refrigerators, cabinets, and around garbage cans, plumbing and other utility installations. Pest driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Repeat if reinfestation occurs.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do not Spray Pets With this Product. Do not treat pets with this product. For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets (N.B. This product is not for use on pets. (Use Bugcon Fly Flea Free registered for direct treatment on the pet) and treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas prior to the treatment with this product.

FOR CRACK AND CREVICE to kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Earwigs, Brown Dog Ticks, Fleas, Carpet Beetles, and Dermestids: Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where the above listed insects hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE AND SPOT TREATMENT ARE NOT PERMITTED.

Flies and Mosquitoes: Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the buildings. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, and garages, where these insects may congregate. Flies and mosquitoes coming to rest on the surfaces will be killed.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing, wash hands after use. If poisoning occurs, get prompt medical aid. Do not apply to plants, animals or humans. Remove pets and fish bowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact. DO NOT CONTAMINATE FOODSTUFF. Do not use in any area where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboard where food or cooking utensils are stored. In home or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash with potable water all surfaces that might contact food before reuse. In meat and food processing plants and food service establishments, treat only when plant is NOT in operation. Remove or cover all food packaging materials, and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before resuming operations. Do not use in rooms where milk is processed, handled or stored. Do not spray near open flame or stove. Product toxic to fish. Do not contaminate any body of water.

STORAGE: Store in a cool area away from heat or open flame.

NOTICE TO USER:

Make the empty container unsuitable for further use and dispose of in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills contact the provincial regulatory agency or the manufacturer.
