DIRECTIONS: Ready to use solution containing 1% crotoxyphos 0.25% dichlorvos. To control stable flies, horn flies, face flies and houseflies.

Livestock Spray: To treat dairy and beef cattle against attacks of above named flies. Spray animals once daily with a coarse spray. Apply at a rate of 60 mL per animal. Spray flanks, legs, brisket, head and neck on each side of the animal, beginning at the tail and moving forward. Spray should be enough to dampen hair. Take care not to spray in animal's eyes. Treat dairy cattle before milking. Wash udders before milking. Do not use more than once a day. May be applied up to the day before slaughter.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not contaminate milk or milking utensils, feed or foodstuffs, streams, lakes ponds, irrigation water, water used by livestock or water used for domestic purposes. Do not store with feed or foodstuffs. Avoid inhalation of spray. Avoid contact with skin and eyes. Wash after using. Keep in original container during storage. Destroy empty container. Keep product away from fire, open flame, lighted electric bulbs and other sources of heat.

FIRST AID: If in eyes or on skin, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, induce vomiting immediately and get medical attention. ATROPINE is antidotal.
